## I. INTRODUCTION

The Victoria Metropolitan Planning Organization (MPO) is responsible for conducting a continuous, cooperative, and comprehensive transportation planning process for Victoria County. As a part of this process, every two years MPO's develop a short-range, multimodal transportation plan, the Transportation Improvement Program (TIP). The TIP lists all federally funded transportation projects programmed within a four-year period for implementation in the Metropolitan Planning Area (MPA).

The following Introduction to the FY 2025- 2028 TIP will provide the reader with the following background and overview: federal legislation and requirements for developing the TIP; the public involvement process for developing the TIP; the project selection process for the TIP; progress from the previous TIP; the MPO's transportation performance measures and anticipated or observed impacts of project implementation.

### A. Transportation Planning Background and History

The Federal-Aid Highway Act of 1962 established the continuous, cooperative, and comprehensive regional transportation planning process for urban areas. This legislation required urban areas to create and implement transportation plans in order to receive federal highway funds. The Federal-Aid Highway Act of 1973 formally established the Metropolitan Planning Organization (MPO) and required one be established for any urbanized area with a population of more than 50,000.

Designated by the Governor in 1982, the Victoria MPO is housed within the City of Victoria Development Services Department and serves as the MPO's fiscal agent. The first decision-making body was the Victoria Urban Transportation Planning Committee, which included state, county, and city officials. In 1994 the Victoria MPO's Metropolitan Area Boundary was amended to coincide with the Victoria County line. The MPO's Urban Area Boundary (UAB) roughly coincides with the city limits of Victoria, which is the only urbanized area and incorporated community within the study area. Today, the Victoria MPO is governed by the Policy Advisory Committee comprised of elected and non-elected officials from the City of Victoria, Victoria County, and the Texas Department of Transportation (TxDOT). The Policy Advisory Committee is the sole decision-making authority for the Victoria MPO, acting as both a technical advisory committee and a policy board in the selection and evaluation of projects for the Victoria MPO.

### B. Purpose of the Transportation Improvement Program (TIP)

There are two primary documents that MPOs develop and maintain to help facilitate the transportation planning process, a long-range transportation plan, the Metropolitan Transportation Plan (MTP), and the Transportation Improvement Program (TIP). The MTP is a multimodal transportation plan that provides the basic framework for the region's transportation planning needs and informs the projects found in the TIP. Figure 1 shows how the MTP impacts the project listed in the TIP and other MPO plans, studies, and programs.



The Transportation Improvement Program (TIP) is a short-range, four-year, fiscally constrained program which must be developed at both the state and metropolitan levels. Updated every two years, the TIP lists all federally funded transportation and transit projects occurring within the metropolitan planning boundary. The projects listed in the TIP are mostly funded with federal funds. However, some projects may be combined with state and local funds. The TIP contains a project listing that includes those projects funded within the four-year period covered by the TIP. The project listing consists of the following project groups:

- Federal and State funded highway projects
- Grouped Projects
- Federal and State funded transit projects.

The Victoria MPO's FY 2025- 2028 TIP identifies priority roadway and transit projects scheduled for implementation between October 2024 and September 2028. This TIP was developed by the Victoria Metropolitan Planning Organization (MPO) in cooperation with local governments, the Texas Department of Transportation (TxDOT), and local transportation agencies. The Victoria MPO developed the FY 2025-2028 TIP in accordance with the metropolitan planning requirements set forth in 23 CFR, Part 450, 49 CFR Part 613, the Fixing America's Surface Transportation (FAST) Act, and continued through the Infrastructure Investment and Jobs Act (IIJA), also known as the Bipartisan Infrastructure Legislation (BIL).

### ***C. Federal Legislation & Requirements for the TIP***

There are various pieces of legislation that impact the development and implementation of the TIP. This section outlines the legislation that impacts the project selection and implementation process that the MPO must consider.

#### **1. SAFETEA-LU**

The 2005 transportation legislation, Safe, Accountable, Flexible, Efficient Transportation Equity Act: A legacy for Users (SAFETEA-LU), required that MPOs provide for consideration of projects and strategies that will serve to advance eight (8) transportation-planning factors:

1. Support economic vitality of the metropolitan area, especially by enabling global competitiveness, productivity, and efficiency.
2. Increase safety of the transportation system for motorized and non-motorized users.
3. Increase security of the transportation system for motorized and non-motorized users.
4. Increase the accessibility and mobility of people and freight.
5. Protect and enhance the environment, promote energy conservation, improve the quality of life, and promote consistency between transportation improvements and State and local planned growth and economic development patterns.
6. Enhance the integration and connectivity of the transportation system, across and between modes, for people and freight.
7. Promote efficient system management and operation; and
8. Emphasize the preservation of the existing transportation system.

## 2. MAP-21

In 2012, Moving Ahead for Progress in the 21st Century (MAP-21) implemented a performance-based approach to transportation planning to help identify the effectiveness of transportation investments. Additionally, MAP-21 reinforced the eight planning factors listed in SAFETEA-LU by establishing seven (7) national performance goals to achieve the following:

1. **Safety** – to achieve a significant reduction in traffic fatalities and serious injuries on all public roads.
2. **Infrastructure Condition** – to maintain the highway infrastructure asset system in a state of good repair.
3. **Congestion Reduction** – to achieve a significant reduction in congestion on the National Highway System (NHS).
4. **System reliability** – to improve the efficiency of the surface transportation system.
5. **Freight Movement and Economic Vitality** – to improve the national freight network, strengthen the ability of rural communities to access national and international trade markets, and support regional economic development.
6. **Environmental Sustainability** – to enhance the performance of the transportation system while protecting and enhancing the natural environment.
7. **Reduced Project delivery delays** – to reduce project costs, promote jobs and the economy, and expedite the movement of people and goods by accelerating project completion through eliminating delays in the project development and delivery process, including reducing regulatory burdens and improving agencies' work practices.

## 3. Fast Act and 23 CFR §460.306

MPOs, in cooperation with the State and public transportation operators are required to develop long-range plans and TIPs through a performance-driven, outcome-based approach to planning for metropolitan areas, ensuring that the transportation planning process will be continuous, cooperative, and comprehensive. MPO's must also provide for the consideration and implementation of projects, strategies, and services, that will address the ten (10) factors listed in the FAST Act, signed into law in 2015. The ten (10) federal transportation planning factors that the MPO must consider when selecting projects for the TIP:

1. Support economic vitality of the metropolitan area, especially by enabling global competitiveness, productivity, and efficiency.
2. Increase safety of the transportation system for motorized and non-motorized users.
3. Increase security of the transportation system for motorized and non-motorized users.
4. Increase the accessibility and mobility of people and freight.
5. Protect and enhance the environment, promote energy conservation, improve the quality of life, and promote consistency between transportation improvements and State and local planned growth and economic development patterns.
6. Enhance the integration and connectivity of the transportation system, across and between modes, for people and freight.
7. Promote efficient system management and operation; and

8. Emphasize the preservation of the existing transportation system.
9. Improve the resiliency and reliability of the transportation system by reducing and mitigating storm water impacts of surface transportation; and
10. Enhance travel and tourism.

#### ***D. Public Involvement Process***

The Victoria MPO's Public Participation Plan (PPP) outlines the MPO's compliance with the Federal requirements specified in MAP-21 and the FAST Act and continued BIL/IIJA. The PPP was adopted by the Policy Advisory Committee on January 9, 2018, and is amended as needed. A summary of the public participation process used for the FY 2025- 2028 TIP is below.

- **Public Review and Comment Period:** **April 3, 2024- May 3, 2024**

This fulfills the PPP's requirement to hold a 30-day public review and comment period prior to approval and formal adoption of the FY 2025-2028 TIP by Policy Advisory Committee adoption

- **Notice of Public Review and Comment Period:** **April 3, 2024**

A notice will be posted at Victoria City Hall, on the Victoria MPO's website, in the Victoria Advocate, and emailed to the MPO's distribution list notifying the public that the draft FY 2025-2028 TIP is open for public comment & review.

- **Public Hearing:** **April 9, 2024**

This fulfills the PPP's requirement to accept public comment and hold a public hearing over the proposed draft prior to the plan's formal approval and adoption by the MPO's Policy Advisory Committee

#### ***E. Project Selection Process***

The project selection process for the TIP takes place through the MPO's current Metropolitan Transportation Plan (MTP) and through discussions with the Texas Department of Transportation (TxDOT) at regularly scheduled Policy Advisory Committee meetings. The following section will continue discussing the TIP project selection process, its relationship with the MPO's MTP and the TIP's project selection process in coordination with TxDOT.

##### **1. The MTP & the FY 2025- 2028 TIP**

Projects are identified and selected from the Victoria MPO's long-range transportation plan, the MTP. Projects in the FY 2025- 2028 TIP were identified and prioritized in the MPO's 2045 MTP. The 2045 MTP prioritized projects using the following criteria:

- Safety,
- Resiliency,
- Reliability and preservation of the transportation system,
- Economic development,

- Efficient operations,
- Congestion,
- Multimodal development,
- Storm-water impacts,
- Local priorities and funding efficiencies, and
- Local impact.

## 2. The 2050 MTP and the FY 2025- 2028 TIP

On April 8, 2025, the Victoria MPO officially adopted the Move Victoria 2050 Metropolitan Transportation Plan (MTP). Projects listed in the 2045 MTP that had not been programmed or implemented were reevaluated using similar alongside new project submissions for the 2050 MTP. Transportation projects were evaluated using a similar set of Goals and Objectives and project evaluation criteria built upon from the 2045 MTP.

## 3. Project Selection Process for the FY 2025- 2028 TIP

The Victoria MPO works closely with the TxDOT Yoakum District to identify potential highway projects, however project selection for the TIP is dependent on funding availability and does not always reflect the exact project ranking in the MTP. To ensure that the programmed projects in the TIP still address the needs and desires of the community, the Policy Advisory Committee discusses the list of projects often at MPO Policy Advisory Committee meetings, but at least on an annual basis.

Project selection for the TIP combines national and regional goals to ensure that the project continues to meet regional and local needs, as well as federal regulations. The Move Victoria 2050 MTP Goals and Objectives are listed, below.

1. Ensure **safety and security** for users of the transportation network.
2. **Preserve and maintain** the existing transportation infrastructure.
3. **Reduce congestion** and improve efficiency on roadways.
4. Support **land use** goals.
5. Invest in **walking and cycling** facilities.
6. Support **economic development**.
7. Improve **environmental sustainability and resilience** to hazards.
8. Improve **public transportation**.
9. Make **equitable investments**.

Using the goals and objectives from the 2050 MTP and the public input received, the project evaluation criteria was developed and used to rank and prioritize transportation projects for programming. The twelve project evaluation criteria from the 2050 MTP are listed, below.

1. Safety and Security
2. Preserve and Maintain Existing Infrastructure
3. Improve System Efficiency

4. Improve Environment and Resilience
5. Support Land Use Goals
6. Preserve ROW or supports development goals
7. Encourage Walking and Cycling
8. Enhance Economic Development
9. Improve Public Transport
10. Ensure Equity
11. Cost Sharing
12. Project Readiness

**F. Progress from FY 2023- 2026 TIP**

The Victoria MPO’s FY 2024- 2026 TIP listed three (3) individually listed highway projects, all scheduled to let for construction in FY 2023. Table 3, below, displays the information and progress on all three of the individually listed highway projects from the FY 2023- 2026 TIP.

## II. PERFORMANCE MEASURES

Federal legislation requires that State DOTs and MPOs carry out a performance-based transportation planning and programming process using the seven national goals outlined under MAP-21 and continued in the FAST Act. Performance-based transportation planning and programming results in tracking performance measures, setting data-driven targets for those measures, selecting projects to help meet those targets, developing plans, and monitoring, evaluating, and reporting progress towards those targets.

State DOTs are responsible for setting their own data-driven targets, however, MPOs can elect to establish their own or support the State DOT's statewide target. The five (5) performance measures that State DOTs and MPOs are responsible for setting data-driven targets for are:

1. Safety,
2. Infrastructure Condition,
3. System Performance,<sup>1</sup>
4. Transit Asset Management, and
5. Transit Safety.

In the following section, the Victoria MPO's adopted performance targets for safety, infrastructure condition, system performance, transit asset management, and transit safety will be reviewed. Furthermore, this section will discuss the projects' anticipated impacts on the MPO's regional transportation performance targets.

### A. Safety Performance Measure Targets

The Victoria MPO adopts safety performance targets, on an annual basis, no more than 180 days after TxDOT sets their targets. The Victoria MPO elects to support and adopt the safety performance measure targets established by TxDOT and published in the Highway Safety Improvement Program Annual Report. In February 2026, the Victoria MPO's Policy Advisory Committee adopted TxDOT's Safety Performance Measure Targets. The Victoria MPO's 2024 Safety Performance Targets are shown in Table 2 below.

The targets identified in Table 2 were developed using a data-driven, collaborative process that aligns with the Highway Safety Improvement Program (HSIP) and the Highway Safety Plan (HSP). TxDOT, in partnership

with local agencies, identifies and programs safety investments into the Highway Safety Improvement Program (HSIP). Projects selected for HSIP investment are based on crash history, roadway characteristics, and traffic calming or other infrastructure design countermeasures that address the type of crashes present. HSIP projects are design-based countermeasures that seek to actively reduce or eliminate traffic fatalities or serious injuries.

### 1. Victoria MPO and Safety Performance

Safety is a key criterion in the selection of projects for the Victoria MPO. The Policy Advisory Committee supports the planning and programming of projects that contribute to the achievement of significantly reducing or eliminating serious injuries or fatalities on roadways and the MPO’s established safety targets. Many of the projects listed in the MPO’s FY 2025- 2028 TIP support achieving the established targets for safety. To learn more about projects and their anticipated impacts to safety, see Appendix C, Supplemental Progress Report on Performance Measures.

### B. Pavement and Bridge Performance Measures- Infrastructure Condition

Every two (2) years the Victoria MPO adopts performance measures targets for infrastructure conditions, these targets measure the condition of pavement and bridge structures on and off the National Highway System (NHS). The pavement and bridge performance targets that the Victoria MPO elected to adopt were established by TxDOT for the years 2022- 2026. The Victoria Policy Advisory Committee adopted the pavement and bridge performance measure targets in April 2023 and readjusted those targets, via Resolution 2025-03 in February 2025. The MPO’s targets for pavement and bridge performance measures are shown in Table 3 below.

### 1. Victoria MPO and Infrastructure Condition Performance

Infrastructure conditions, like pavement and bridge, are another key criterion in selecting transportation projects for the FY 2025- 2028 TIP. While almost every construction project contributes to an increase in the percentage of pavement in “good” condition, specific projects that the MPO anticipates will directly contribute to achieving the targets for pavement and bridge conditions can be found in Appendix C.

### C. System Performance Measures Targets

System Performance Measures attempts to monitor and measure the congestion on interstate roadways through the travel time reliability index. As there are no interstate miles within the Victoria MPO’s planning area, the Victoria MPO is not required to adopt these performance measure targets; however, the MPO did originally adopt NHS travel time reliability measures in November 2018 and reaffirmed them in August 2021. Table 4, below, shows the previously adopted and affirmed system performance targets for the Victoria MPO.

#### 1. Victoria MPO and System Performance

As there were no recent state targets related to system performance for non-interstate travel, the Victoria MPO has decided to demonstrate its support of the State DOTs efforts to reduce congestion and increase efficiency on the transportation system. Even though the Victoria MPO lacks interstate lane miles, congestion and congestion management are still vital components in project evaluation for the MTP.

### D. Transit Asset Management Performance Targets

The Transit Asset Management (TAM) Rule was developed by the Federal Transit Administration (FTA) to establish a strategic and systematic process of operating, maintaining, and improving public capital assets effectively through their entire life cycle. The TAM’s primary objective is to enhance safety, reduce maintenance costs, increase reliability, and improve performance. The TAM prioritizes funding based on the condition of transit assets, in order to maintain a “state of good repair.” The TAM performance targets are adopted annually by the MPO’s Policy Advisory Committee. Most recently reaffirmed in September 2025, the MPO’s TAM performance targets are listed in Table 5, below.

#### 1. Victoria MPO and TAM Performance

Public transit capital projects included in the TIP align with the TAM planning and target-setting processes undertaken by Victoria Transit in conjunction with the Victoria MPO. Investments are made in alignment

with TAM plans, with the intention of maintaining public transit vehicles and facilities in good repair and meeting transit safety targets. Most of the transit Projects listed in the FY 2025- 2028 TIP will almost certainly contribute to maintaining a state of good repair for Victoria Transit, and assist in achieving the established TAM performance Targets; further discussion on this can be found in Appendix C.

### E. Transit Safety Performance Targets

Public Transit Agency Safety Plans (PTASP) are a way for transit providers to monitor and improve the safety of their transit systems. A key component of the process is monitoring and establishing targets for four required performance measures:

- **Fatalities:** total number of reportable fatalities and rate per chosen interval of vehicle revenue miles by mode.
- **Injuries:** total number of reportable injuries and rate per chosen interval of vehicle revenue miles by mode.
- **Safety Events:** total number of reportable events and rate per chosen interval of vehicle revenue miles by mode.
- **System Reliability:** mean distance between major mechanical failures by mode.

Victoria Transit establishes and reports targets annually, and the Victoria MPO adopts or reaffirms them annually as well. The Transit Safety Performance Targets were last adopted in September 2025 and are shown in Table 6, below.

#### 1. Victoria MPO and Transit Safety Performance

Safety for all modes of transportation is a key criterion in project evaluation for the Victoria MPO. Victoria Transit establishes Transit Safety performance targets to maintain and improve safety for riders on Fixed, Demand Response, and Fixed Route Commuter routes within the Victoria MPO. Projects listed in the FY 2025- 2028 TIP that will have an anticipated impact on Transit’s Safety Performance Targets are listed throughout this document, but can be found specifically in Appendix C.







Excavation will begin in the northbound lanes beginning next week on the Crestwood project. The Mill/Overlay project has been awarded, and the Ben Wilson project is complete, and the roadway is now open.

The US 59 project from US 87- SH 185 is moving right along. The contractor is almost complete with paving, they are still rehabbing the bridge deck, and the hot mix should be complete by the end of the week. SH 185 Northbound Reconstruction project will begin in the next few weeks.

The Hot Mix project from US 59 to Navarro will start this summer. The Loop 463 bridge widening project is about to start Phase 2. Project is projected to be complete in the spring of 2025.

The proposed amendments to the Victoria MPO's FY 2025-2028 TIP will be available for citizen review and comment starting Tuesday, March 3, 2026, and will conclude on Friday, March 13, 2026. A public hearing on the proposed amendments, as required by the MPO's Public Participation Plan (PPP), will be held on Tuesday, March 10, 2026, at 2:00 p.m. in Conference Room 205, 702 N. Main St, Victoria, Texas. All interested parties are encouraged to attend or submit comments.

## **IX. APPENDIX C: SUPPLEMENTAL PROGRESS REPORT ON PERFORMANCE MEASURES**

Appendix C is supplemental to the Victoria MPO's FY 2025- 2028 TIP; however, it provides an explanation of the anticipated progress towards the Victoria MPO's adopted performance measures, listed throughout Section II of the FY 2025- 2028 TIP, and the transportation projects listed in the FY 2025- 2028 TIP. As the FY 2025- 2028 TIP is amended, Appendix C will reflect the anticipated changes to the MPO's Performance Measure Targets and the projects added, revised, or removed.

### ***A. FY 2025- 2028 TIP Projects and Anticipated Progress Towards the MPO's Established Performance Measure Targets***

The following section will explain the anticipated progress towards the Victoria MPO's adopted Performance Measure Targets and the projects listed throughout the FY 2025- 2028 TIP. A brief review of the project selection process is listed below; to learn more about the MPO's performance measures see Section II, "Performance Measures."

The Transportation Improvement Program (TIP) is a short-range list of fiscally constrained transportation projects that cover a four-year window for the designated metropolitan planning area boundary. As demonstrated in the Victoria MPO's Memorandum of Understanding (MOU), MPO staff work closely with the Texas Department of Transportation's (TxDOT) Yoakum district office to select and prioritize transportation projects within Victoria's MPA that meet the following evaluation criteria:

1. Safety and Security
2. Preserve and Maintain Existing Infrastructure
3. Improve System Efficiency
4. Improve Environment and Resilience
5. Support Land Use Goals
6. Preserve ROW or supports development goals
7. Encourage Walking and Cycling
8. Enhance Economic Development
9. Improve Public Transport
10. Ensure Equity
11. Cost Sharing
12. Project Readiness

### ***B. Programming Projects in the FY 2025- 2028 TIP***

The projects programmed in the Victoria MPO's FY 2025- 2028 TIP are discussed by the Policy Advisory Committee regularly to ensure that the needs and desires of the community are addressed accordingly. The MPO collaborates with TxDOT and the Golden Crescent Regional Planning Commission (GCRPC)-Victoria Transit to determine, prioritize, and implement transportation projects within the Victoria Metropolitan Planning Area Boundary. This is consistent with the Memorandum of Understanding (MOU) between the Victoria MPO, TxDOT, and GCRPC-Victoria Transit which mandates that the three agencies

work together to determine performance-based planning measures, consult with each other regarding relevant data, and maintain compliance with State and Federal laws. The MOU is an agreement between the MPO, TxDOT, and GCRPC-Victoria Transit to work together to meet the needs of the community and carryout a continuous, cooperative, and comprehensive transportation planning process to achieve the set performance measure targets established by TxDOT and Victoria Transit and adopted by the Victoria MPO.

## **1. Anticipated Impacts of Highway Projects Listed in the Victoria MPO's FY 2025- 2028 TIP**

The following section will review the MPO's listed highway projects and their anticipated impacts on the regional transportation network, as well as their impacts in the MPO achieving the established performance measure targets in safety and infrastructure conditions, along with other positive anticipated impacts to the transportation network.

**CSJ: 0842-03-037**

**Highway:** FM 236

**Limits To:** FM 622

**Limits From:** US 77

**Project Description:** Add 3 Lanes to Convert to a 4-Lane Facility with a Continuous Left Turn Lane Including Widen Pavement, Realign of Roadway, Construct Undivided Lanes, Placement of ACP, Upgrade Standard, and Proposed Drainage Modifications

**Safety:** Between 2019 and 2023 there were a total of 33 crashes that involved 59 vehicles or units and 64 persons. For the same 5-year period, 2019 to 2023, 1 fatality occurred in 2023 and 1 suspected serious injury occurred in 2022. Most crashes recorded for this period list speed and failure to yield to oncoming traffic while turning as the top contributing crash factors. The MPO reasonably anticipates this project to have a positive impact on safety and the MPO's established Safety Performance Measure Targets. The project will contribute to the MPO's safety targets due to the realignment of the roadway and the addition of a continuous left-hand turn lane, to allow for safer travel, slower speeds, and better visibility when turning into oncoming traffic. Finally, this segment is a high trafficked freight corridor, the additional lane for travel will allow for motorists to pass freight and/or slow traffic safely when needed.

**Infrastructure Condition:** The MPO anticipates that this project will improve pavement conditions along FM 236. With the construction and addition of another travel lane and upgrade to the standard and ACP, this project is anticipated to improve the infrastructure condition along FM 236. Although FM 236 is not on the NHS, the MPO still monitors the performance of transportation investments and their contribution to the MPO achieving its adopted transportation planning performance measure targets.

**CSJ: 0432-02-101**

**Highway:** SH 185

**Limits To:** .1 mile south of King Rd

**Limits From:** 7th St.

**Project Description:** Add Grade Separation Bridge, Including Widen Pavement, Realign of Roadway, Placement of ACP, Upgrade Standard, Construct Interchange, and Proposed Drainage Modifications

**Safety:** Between 2019 and 2023, there were a total of 25 crashes that involved 55 vehicles or units and 72 persons. During this period there were a total of 2 fatalities reported and 3 suspected minor injuries, with the top contributing crash factors being speed and driver inattention. The recorded fatalities that occurred along this roadway segment took place in 2023 and 2021. The MPO anticipates that this project will contribute to the MPO's safety performance targets through the construction of a grade separated interchange which will allow for traffic to avoid the at-grade railroad crossing at that location currently.

**Infrastructure Condition:** SH 185 is not listed on the NHS, however, as mentioned previously, the MPO still monitors programmed projects and their contribution to the MPO's established performance measures. The project is anticipated to improve infrastructure conditions along this portion of SH 185. Not only will the project upgrade pavement standards, but it will also build an interchange and add grade separation. The MPO anticipates that the new addition of a bridge and new pavement will have a positive impact on infrastructure condition along the segment of SH 185.

**Project Remarks (P7 Remarks):** Add rail grade separation bridge, including widen roadway pavement to accommodate wider shoulders and pedestrian sidewalk elements, realign roadway horizontally and vertically to meet current design standards while minimizing right of way, environmental, utility, and railroad impacts, placement of ACP, Upgrade to Standard, Construct Interchange, and Proposed Drainage Modifications. YS40-Railway- Highway Crossings Program.

**CSJ: 0497-06-002**

**Highway:** FM 616

**Limits To:** 1.10 miles north of SH 185

**Limits From:** SH 185

**Project Description:** Add Grade Separation Bridge, Including Widen Pavement, Realign of Roadway, Placement of ACP, Upgrade Standard, Construct Interchange, and Proposed Drainage Modifications

**Safety:** Between 2019 and 2023 there were a total of 3 crashes involving 5 vehicles or units and 8 persons. Of the three crashes on this segment of FM 616, none were fatal or suspected serious injury crashes. This, however, doesn't negate the need for safety work in and around this area. This project is specifically dedicated to safety by raising an at-grade, busy railroad crossing to allow for the multimodal safe and efficient flow of people and goods. The MPO reasonably anticipates, like with CSJ 0432-02-101, that this project will contribute to the MPO's established safety performance measures and increase safety for motorized, non-motorized, and freight rail.

**Infrastructure Condition:** Like with CSJ 0432-02-101 FM 616 is not listed on the NHS, but the MPO anticipates a positive impact on the bridge and pavement from this project due to the construction of a new bridge and new pavement laid over the specified project area.

**Project Remarks (P7 Remarks):** Add rail grade separation bridge, including widen roadway pavement to accommodate wider shoulders and pedestrian sidewalk elements, realign roadway horizontally and vertically to meet current design standards while minimizing right of way, environmental, utility, and railroad impacts, placement of ACP, Upgrade to Standard, Construct Interchange, and Proposed Drainage Modifications. YS40-Railway- Highway Crossings Program.

***i. AMENDMENT #4 TO THE FY 2025- 2028 TIP AND PROGRESS TOWARDS THE MPO'S PERFORMANCE MEASURES- HIGHWAY***

On Tuesday, September 23, 2025, the Policy Advisory Committee approved the fourth amendment to the FY 2025-2028 TIP. A summary of the modifications to the Victoria MPO's TIP for 2025-2028 is available in Appendix E. MPO staff expect no significant impact on highway performance measures from this amendment.

**2. Anticipated Impacts of Transit Projects List in the Victoria MPO's FY 2025-2028 TIP**

The transit projects listed in the FY 2025- 2028 TIP are all anticipated to contribute to the achievement of the MPO's established Transit Asset Management and Transit Safety Performance Targets. The FY 2025-2028 TIP Transit listings show investments in capital stock, like buses, shelters, and more, which will assist Victoria Transit and the MPO in achieving State of Good Repair (SGR) performance targets. Finally, Transit's capital investments are also expected to contribute to the established Transit Safety performance measure targets, thanks to the continued upkeep and monitoring of public transit assets and their condition.

***ii. AMENDMENT #1 TO THE FY 2025- 2028 TIP AND PROGRESS TOWARDS THE MPO'S PERFORMANCE MEASURES***

The Policy Advisory Committee approved the first amendment to the FY 2025- 2028 TIP on Tuesday, January 14, 2025. A summary of the first amendments changes to the Victoria MPO's FY 2025- 2028 TIP can be found in Appendix E. MPO staff do not anticipate any changes to the established Victoria Transit performance measures due to this amendment.

***iii. AMENDMENT #2 TO THE FY 2025- 2028 TIP AND PROGRESS TOWARDS THE MPO'S PERFORMANCE MEASURES***

The Policy Advisory Committee approved the second amendment to the FY 2025- 2028 TIP on Tuesday, April 8, 2025. A summary of the changes to the Victoria MPO's FY 2025- 2028 TIP can be found in Appendix E. MPO staff anticipate a slight increase in the MPO's and Transit's SGR targets.

***iv. AMENDMENT #3 TO THE FY 2025- 2028 TIP AND PROGRESS TOWARDS THE MPO'S PERFORMANCE MEASURES***

The Policy Advisory Committee approved the third amendment to the FY 2025- 2028 TIP on Tuesday, May 13, 2025. A summary of the changes to the Victoria MPO's FY 2025- 2028 TIP can be found in Appendix E. MPO staff anticipate a slight increase in Victoria Transit's Safety and SGR targets.

***v. AMENDMENT #4 TO THE FY 2025- 2028 TIP AND PROGRESS TOWARDS THE MPO'S PERFORMANCE MEASURES- TRANSIT***

On Tuesday, September 23, 2025, the Policy Advisory Committee approved the fourth amendment to the FY 2025-2028 TIP. A summary of the changes to the Victoria MPO's FY 2025-2028 TIP is available in Appendix E. MPO staff expect a modest rise in Victoria Transit's SGR assets following this amendment.

***vi. AMENDMENT #5- TO THE FY 2025-2028 TIP AND PROGRESS TOWARDS THE MPO'S PERFORMANCE MEASURES- TRANSIT***

On Tuesday, March 10, 2026, the Policy Advisory Committee approved the fifth amendment to the FY 2025-2028 TIP. A summary of the changes to the Victoria MPO's FY 2025-2028 TIP is available in Appendix E. The MPO reasonably anticipates that this amendment will contribute to Victoria Transit's State of Good Repair targets, as identified stops are upgraded or modified with the available funds from this amendment.
